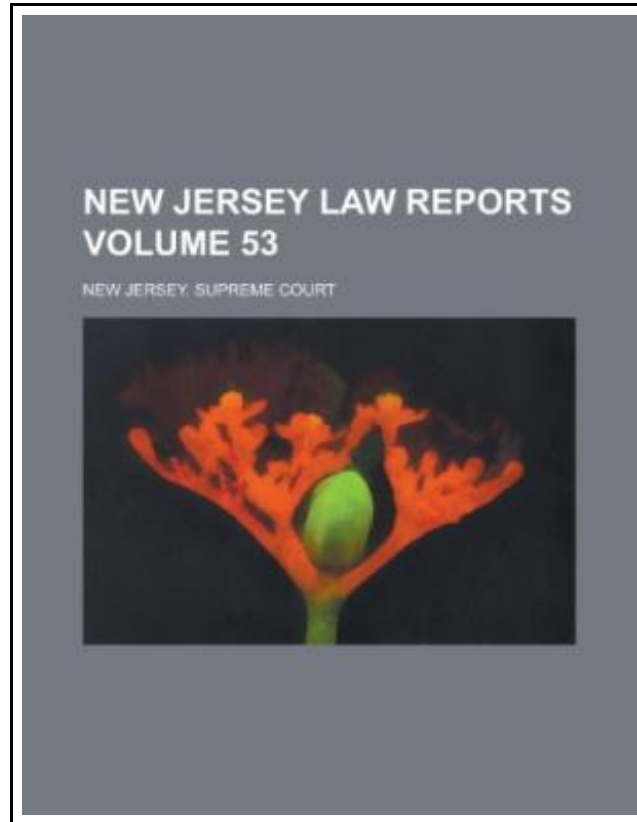

By the law of 1889 it is made the duty of the collector to publish the statement in certain newspapers of the county designated by the governor and comptroller, in pursuance of the act of the legislature. The board of freeholders may cause the publication to be made in papers other than those designated by the governor and comptroller, but the county collector must publish in the papers so designated. The law is mandatory, and there is no necessary conflict between the general and special law. If these laws were in conflict, the general law of 1889 applies to all counties, and contains a general repealing clause, and therefore supersedes the special act. It would not be a general law unless it applies to all counties where financial. Williamson, 15 Vroom 165. An interpretation of the law of 1889 must be adopted which will uphold it as a general law. The limitation of thirty days in the general law of 1889 refers to the time within which the board of freeholders may, designate additional newspapers in which the statement shall be published, and not to the time within which the collector shall publish in the papers designated by the governor and comptroller.
